The Keep Horry County Beautiful Committee met on Tuesday, March 19, 2024 at 11:37am at the Government & Justice Center, Multipurpose Room B in Conway, SC 29526.

In accordance with the SCFOIA, notices of the public meeting were sent to the press (and other interested persons and organizations requesting notification) providing the agenda, date, time and place of the meeting.

CALL TO ORDER

Chairman Trapper Fowler called the meeting to order at approximately 11:37 AM.

PLEDGE

Chairman Fowler led the Pledge of Allegiance. A quorum was obtained at 11:39 AM when Edna Dewitt entered the meeting.

INTRODUCTION OF MEMBERS

Chairman Fowler invited the Committee and meeting attendees to introduce themselves.

PUBLIC INPUT

Chairman Fowler invited Betsy Faye to speak.

Ms. Faye updated the Committee on the beautification efforts in the Covington Lakes Medians. Ms. Faye stated that 14 crepe myrtles and 13 holly trees had been moved due to upcoming road construction. Three palm trees couldn't be moved. The effort cost Beautify Carolina Forest \$4000. They applied for Tree Mitigation Funds from the Planning Department to move the trees but had yet to hear back about the application. Ms. Faye stated that there may have been an issue with the quotation for the work requested for the application.

Ms. Faye stated that Beautify Carolina Forest collects 150-170 bags of trash monthly in addition to mulching the medians with the help of a Solid Waste Authority grant. There are currently

eleven medians with encroachment permits for plantings and all are currently planted. No new plantings are needed at this time.

APPROVAL OF PREVIOUS MEETING MINUTES

Approval of Meeting Minutes 11.28.2023

Chairman Fowler asked that the Committee take a moment to review the Meeting Minutes from November 28, 2023. Catherine Watts made a motion to approve the meeting minutes from 11.28.2023, noting a needed correction of one scribners error. Vincent Lehotsky seconded the motion. *The motion to approve the Meeting Minutes from November 28, 2023 carried unanimously.*

Approval of Meeting Minutes 1.30.2024

Chairman Fowler asked that the Committee take a moment to review the Meeting Minutes from January 30, 2024. Catherine Watts made a motion to approve the meeting minutes from 1.30.2024. Vincent Lehotsky seconded the motion. *The motion to approve the Meeting Minutes from January 30, 2024 carried unanimously.*

PRESENATION

Litter Index Results and Community Clean-Up Program Update

Chairman Fowler introduced the agenda item and invited staff to give the presentation. Ashley Cowen gave a brief presentation of the Litter Index Results. Ms. Cowen stated that overall the Index revealed an increase in litter countywide except for the Area 6 and Area 7 which are Carolina Forest, Longs, Daisy, the east side of Loris, highway 905, and Conway portion of hwy 90. Ms. Cowen stated that staff have shared the litter index results with Horry County Police so they can target enforcement. Staff needs the Keep Horry County Beautiful Committee's support to target litter reduction in these areas and other undocumented litter problem areas. Staff needs KHCB Committee support to target adoption groups and Community Cleanup Program participants.

Ms. Cowen stated that the following are new 2 year adoption groups for 2023:

- 1. Bluegreen Vacations Harbour Lights Resort
 - Location: Backstage Blvd from Harbour lights to Fantasy Harbour; and Fantasy Harbour Dr from George Bishop Pkway to Backstage Blvd.
 - Adoption period January 2023- January 2025
- 2. Cowen Family
 - Location: Browns Chapel Ave, Conway
 - Adoption period April 2023 April 2025
- **3.** South Carolina Trail Stalkers
 - Location: International Drive from Wheatfield Drive to Hwy 90
 - Adoption period November 2023-November 2025
- Ms. Cowen stated that the following are 1-time cleanups from 2023:
 - 1. St. Michaels Environmental Club, Catholic School : September 9, 2023 *Moved to October due to rain*
 - 2. Jennifer Nichols Day of Service : September 9, 2023

- 3. The Pines of St. James : April 22, 2023
- 4. Popular Community Cleanup October 7, 2023 *cleaned up 3 times*
- 5. Talkin' Trash Community Cleanup Day April 1, 2023 * three locations*
- 6. Carolina Forest Rotary Club September 9, 2023
- Ms. Cowen stated that the following are 2-year adoptions that are expiring in 2024:
 - 1. The Causey Girls (Long Bay Rd) : through September 2024
 - 2. Beautify Carolina Forest (Carolina Forest Blvd, River Oaks Dr, International Dr, Frontage Rd B-2, Towne Center Pkwy, Postal Way, Gardner Lacy Dr, Renee Dr, Carolina Commercial Dr, Carolina Exchange, Oakmoor and Elmore Rd, Glenforest Rd, and parts of Berkshire Forest)
 - 3. Carolina Forest Democratic Club (Oakheart Rd)
 - 4. Coastal Leadership Academy (Palmetto Pointe Blvd) : through February 2024
 - 5. Woodbury Community (Woodbury) : through February 2024

Staff updated the committee about upcoming Earth Month Events. Catherine Watts mentioned an April 13th Rain Barrel event.

Staff Updates

Staff announced that the resolutions to recognize Keep Horry County Beautiful Volunteers and the Solid Waste Authority would be heard at County Council in the month of April. Dates were to be announced.

Board Member Updates

Vincent Lehotsky stated that he is continuing to clean River Oaks Drive. He stated that he cleaned the road before the primary elections. He noted that he noticed a man's trash fall off his car and he picked it up, instead of calling the police. Mr. Lehotsky also noted that non-covered trucks continued to be an issue. Vincent also stated that the Special Events Permit do not include anything about recycling.

Trapper Fowler announced that the City of North Myrtle Beach is considering a plastic bag ban, including an amendment for thicker plastics. They are currently working to clean up the language. Trapper inquired if the Committee wanted to send a letter of support. Mr. Fowler requested a brief history of the Committee's prior discussions on single-plastics at a future meeting.

Cassandra LaValley announced upcoming Earth Month Events for CCU and the Eco Reps.

Catherine Watts inquired about receiving emails.

Edna Dewitt inquired about the Bradford tree giveaway replacement programs.
