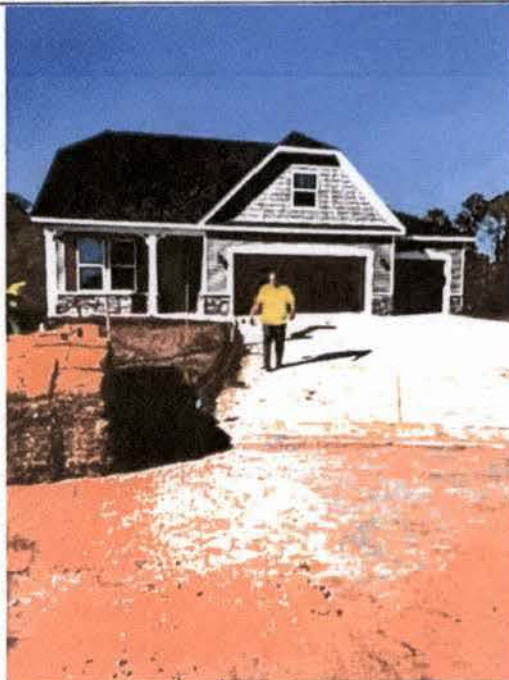

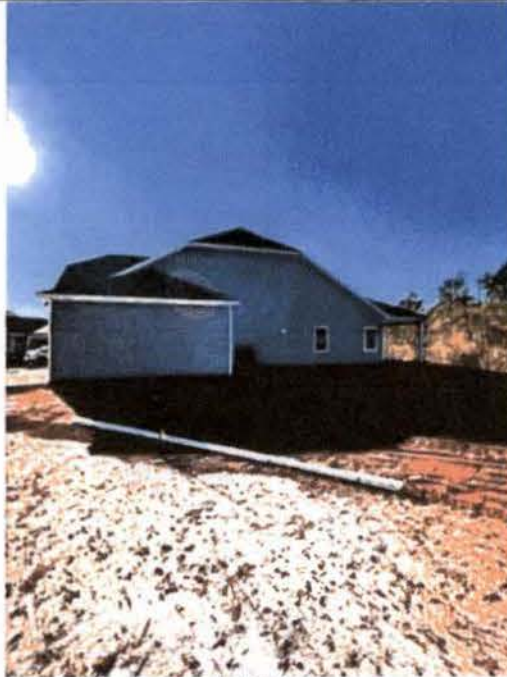

Photo Three Caption RIGHT VIEW 12/15/21

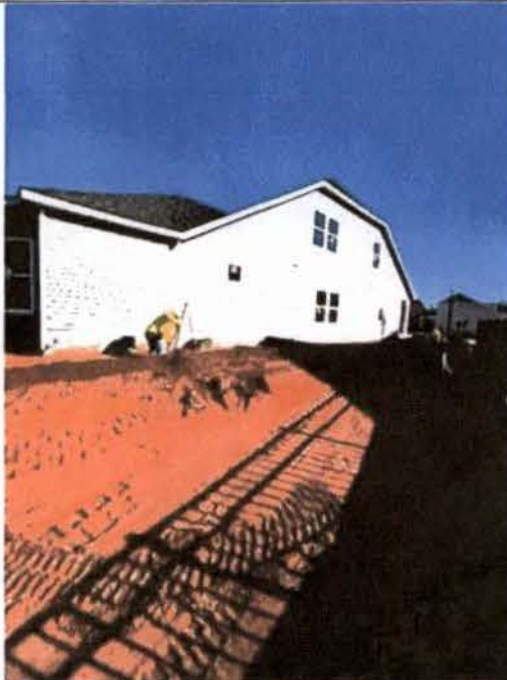
