

MINUTES
HORRY COUNTY COUNCIL
REGULAR SESSION
February 15, 2005
6:00 pm

In accordance with the FOIA, notices of the meeting were provided to the press stating the time, date, and place of the meeting.

CALL TO ORDER: Chairman Gilland called the meeting to order at approximately 6:00 p.m.

INVOCATION: The Honorable Carl Schwartzkopf gave the invocation.

PLEDGE OF ALLEGIANCE: The Honorable Marion Foxworth led in the pledge.

PUBLIC INPUT:

1. Cheryl Vereen came forward to speak on Deferring Rezoning Requests but requested to be placed on public input for the March 15th meeting to speak on the issue at that time.
2. James Millward spoke regarding the Police Department. He thanked the Department for their help regarding his daughter-in-law who had been missing for two weeks. He suggested that Council consider having a webpage of missing persons, missing persons information on the government access channel, and that *The Sun News* have a page of missing persons.
3. Bog Fogner stated that the Veterans Memorial had won the South Carolina and North Carolina award for best public monument of the year and had been nominated for the national award. He presented an award to John Boyd, Lisa Bourcier, County Council, and Horry County Maintenance Department. He further stated a monument would be placed at the Myrtle Beach VA Clinic on March 21st.

Chairman Gilland closed public input.
