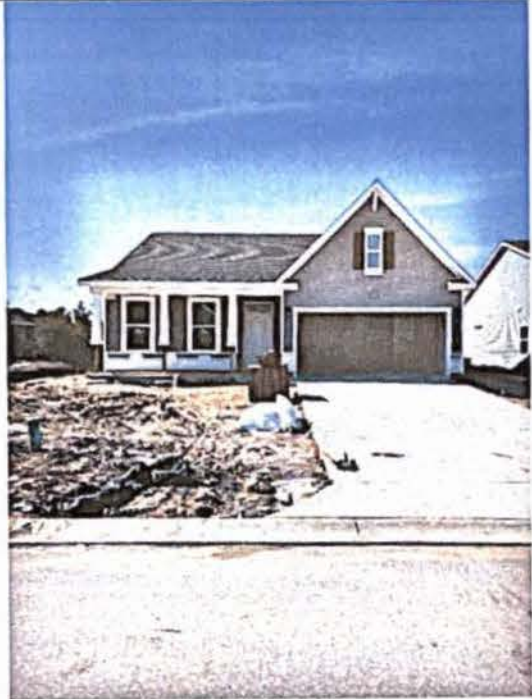

Photo One Caption FRONT VIEW 2-24-22

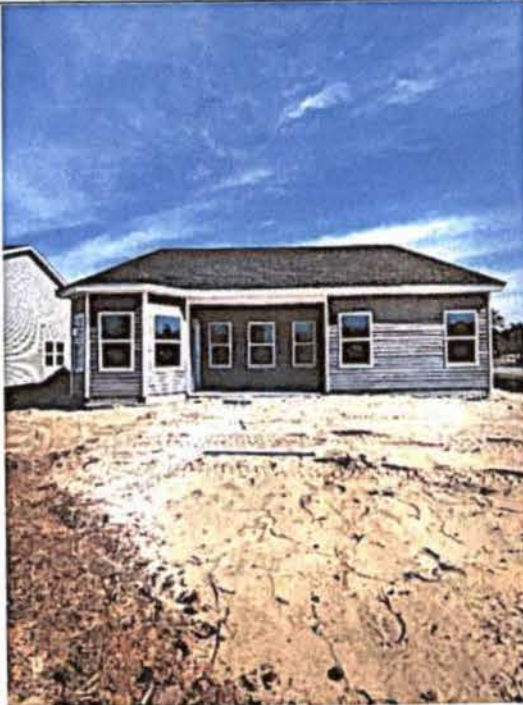
