First reading of <u>Ordinance 200-07</u> to amend the FY 2008 Budget so as to authorize the appropriation of \$400,500 from the County's General Fund and to designate and assign such funds to Coast RTA. **Mr. Grabowski moved to approve, seconded by Mr. Frazier.** Mr. Weaver spoke briefly on the litigation with the casino boats. **The motion failed.
