



# 2024 HORRY COUNTY LOCAL HISTORICAL SITES AND STRUCTURES HIGH SCHOOL VIDEO CONTEST



## Objective:

The objective is for high school students to create local history related videos, telling the story of a structure or a site within Horry County and thereby increasing their awareness of local history and enhancing the public's knowledge of local historical structures or sites within Horry County.

## Eligibility

All High School Students (grades 9 through 12) in Horry County are currently eligible.

## Requirements

1. Your school must be in Horry County.
2. The contest is also open to students in a homeschooling program that are residents of Horry County.
3. Your video must be produced according to specific criteria ([check the Recording Criteria](#)).
4. You must submit application materials (check the Application Materials List).
5. You must produce a video based upon local history within Horry County.
6. Video content, including narration must **not** be read word for word from already published material. This may result in disqualification of your video.

## Awards

Participating students are eligible for the following prizes:

**1<sup>st</sup> Place - \$250**

**2<sup>nd</sup> Place - \$150**

**3<sup>rd</sup> Place - \$100**

All participants are invited along with their families, classmates, teacher, and principal, to the Awards Ceremony, held in May, in Conway, SC. Winners will be presented with a certificate and picture of winners and a press release will go out to the media across Horry County.

Videos may be displayed on Horry County's Public Access Government Channel and shared with local media and using social media outlets to promote the County's historical resources.

- Digital images (2-3 in .jpg format) which convey important themes or characters within your video which may be used for future print advertising or to promote the contest

## GENERAL RULES OF CONTEST

The video must be recorded on a DVD or flash memory stick. In order for your video to be eligible for this contest, it needs to meet specific criteria:

1. The subject of the video must be a historical structure or site within Horry County. A historical structure (or site) must be at least 50 years old. Your video must detail how old the structure or site is or it will be disqualified.
2. Your video should be interesting and/or entertaining. A simple description of a site or structure will not adequately meet this qualification. Consider interviewing community or family members on camera to obtain both footage and stories about a site. Photographs and documents can also add to this standard.
3. Your video must be no longer than 3 minutes. Videos which exceed this standard will be disqualified. Submitting a video shorter than 3 minutes is entirely acceptable and in no way affects the judging of your video.
4. "Historical" is sometimes subjective (other than the 50 year requirement – See #1). You may use this video to make an argument that a site or structure not typically seen as historic should be seen in that light. A person may not be considered as historical for this contest. Having a few great photos from your production could put you in local newspapers or magazines advertisements for historic preservation.
5. Your video will be judged on the following:
  - a. Incorporation of local history
  - b. Creativity, originality, and impact
  - c. Informational content
  - d. Entertainment value/Interest level
  - e. Accuracy of information
  - f. Production quality
6. Be considerate of the location of the subject of your video. The violation of any laws, including trespassing, may disqualify you from this contest. Refrain from damaging any natural features or potentially invaluable historic features while making your video. The subject matter of your video should **not** include the collection, alteration, repair, or searching for archaeological artifacts, headstones or other sensitive features.
7. Understand that the motive behind this contest is to further your knowledge and the knowledge of your community of historic sites and structures. **Communicating this objective should be your primary focus.**

8. Permission from the owner or manager of the property that is the subject matter of your video must be obtained prior to filming. Failure to do so may result in the disqualification of your submission.
9. Team projects are acceptable. Only one potential prize will be issued per submission.
10. Be sure to include a Photographic Release for **EVERY** person appearing in your video, **INCLUDING** people appearing in the background.
11. Persons serving on the Horry County Historic Preservation Commission may not appear visually or audibly in the video.
