HORRY COUNTY HOME CONSORTIUM
2026-2027 Annual Action Plan

Horry County, South Carolina is receiving comments regarding the proposed 2026 – 2027 Annual Action Plan. While annual allocation amounts have not yet been announced, Horry County anticipates receiving the following funds from the Department of Housing and Urban Development:

- \$1,892,350 in Community Development Block Grant funds (to be spent in Horry County and City of Myrtle Beach)
- \$168,117 in Emergency Solutions Grant funds (to be spent in Horry County)
- \$984,438.54 in HOME Investment Partnerships Program funds (to be spent in Horry, Georgetown, & Williamsburg Counties)
