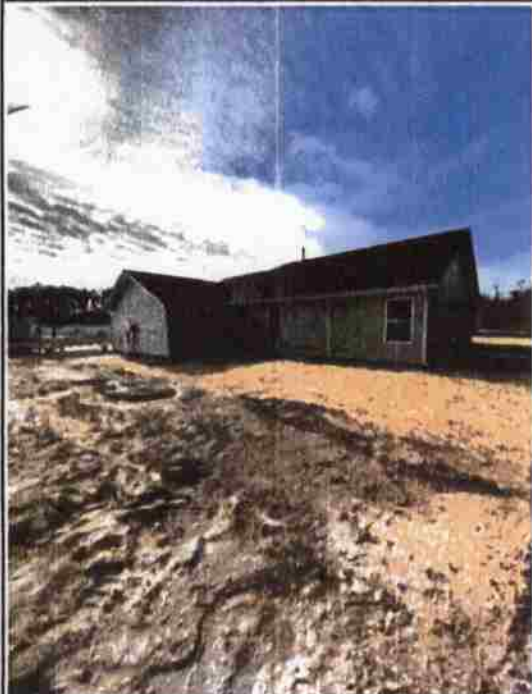

Photo Three Caption RIGHT VIEW 12-4-20

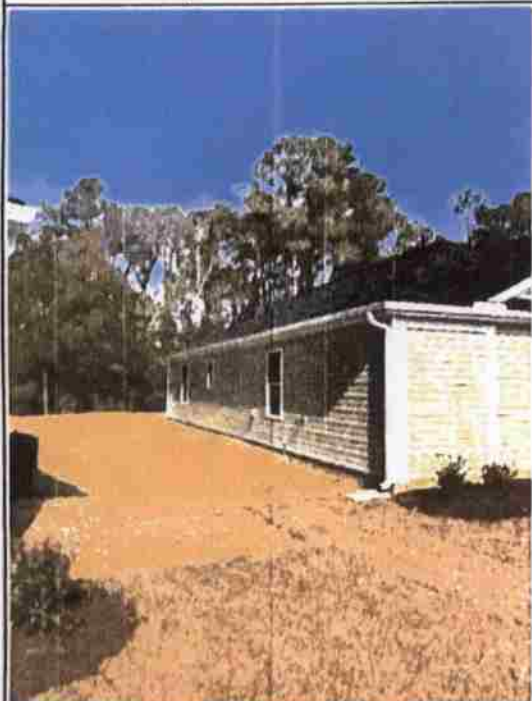
