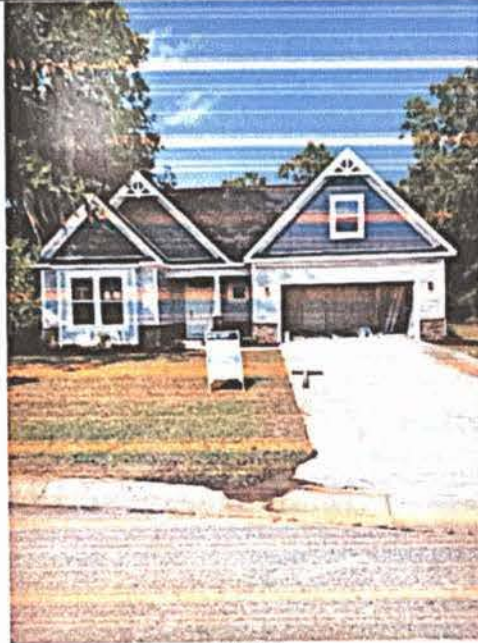

Photo One Caption FRONT VIEW 5-19-22

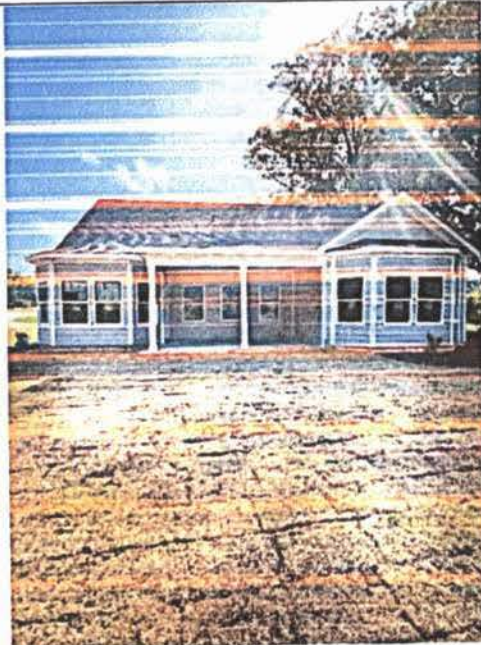

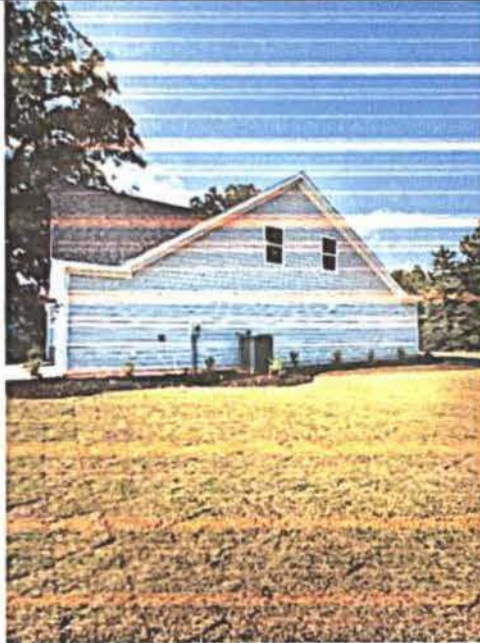

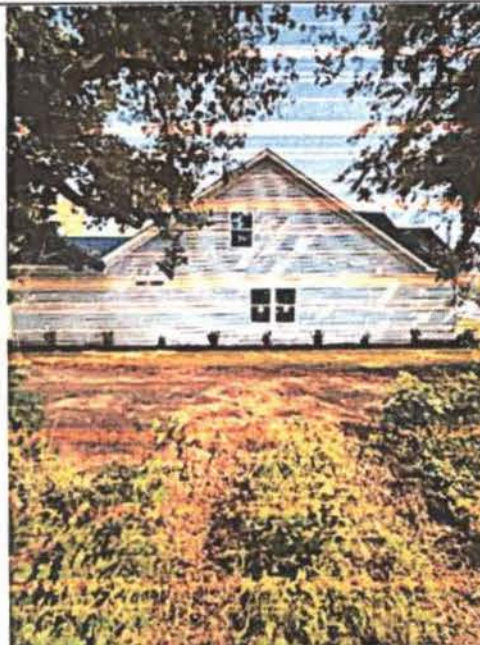
