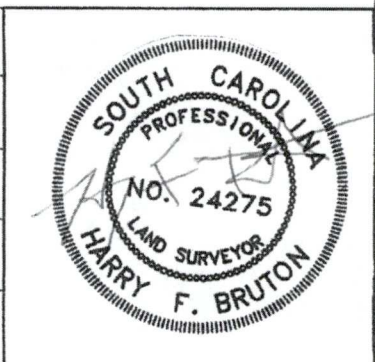

Additional area at rear of home on crawl space at 17.3' totaling 1,144 sq.ft. equipped with 6 vents of which only 3 are within 1' of grade totaling 200 sq.in. of vent space. Lowest mechanicals servicing the home is the hot water heater on left side at 16.5'. Heat pump on right side at 18.0'.

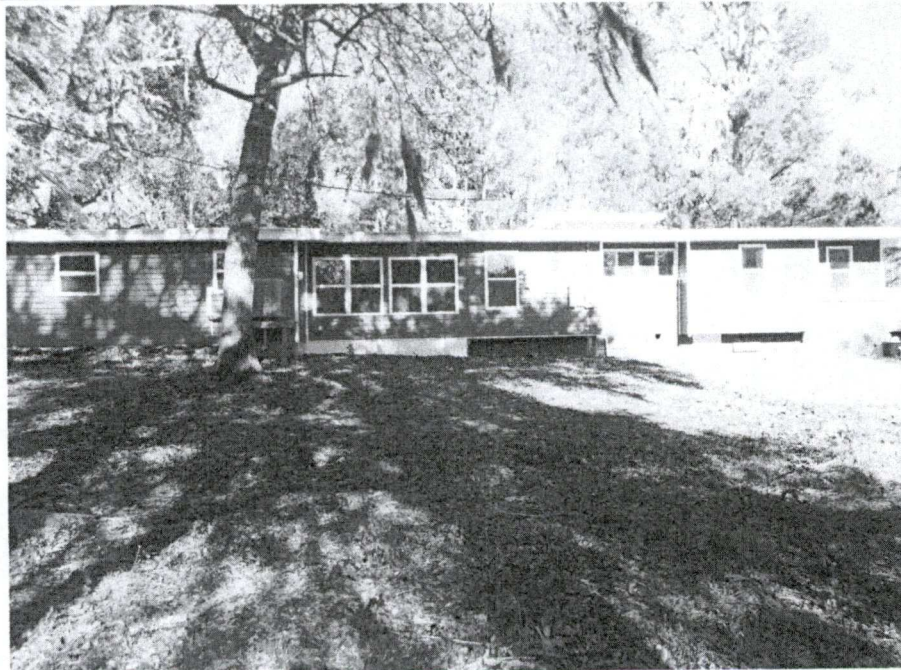
