**CALL TO ORDER:** Chairman Gilland called the meeting to order at approximately 6:00 p.m.

Consideration of a Motion to override the millage rate limitation in order to increase the Waste Management Fund 06 millage more than the previous year's Consumer Price Index. Chairman Gilland explained the motion would be to approve a 2-mil increase in the Waste Management Fund. She opened the floor for public comment. There was none.
