HORRY COUNTY COUNCIL
REGULAR MEETING
November 15, 2005
6:00 p.m.**

CALL TO ORDER: Chairman Gilland called the meeting to order at approximately 6:05 p.m.

INVOCATION: Mr. Worley gave the invocation.

Resolution R-152-05 congratulating the Myrtle Beach High School Tennis Team on winning the State Tennis Championship. Mr. Lazarus presented the resolution to the tennis team and coach. **Mr. Lazarus moved to approve, seconded by Mr. Foxworth. The motion passed unanimously.**

Resolution R-149-05 authorizing and approving Accommodations Tax funding. **Mr. Hardee moved to approve, seconded by Mr. Lazarus. The motion passed unanimously.**

Resolution 151-05 authorizing the administrator to execute a subrecipient agreement with NESAs concerning the regional airport study and use of FAA funds. **Mr. Frazier moved to approve, seconded by Mr. Hardee. Mr. Foxworth moved to amend to strike from the subrecipient agreement all mention of bids and authorize use of the Federal grant for the bid, seconded by Mr. Ryan.** Mr. Foxworth stated that when the bidding process was concluded, the RFQ committee would make a recommendation to the Administration Committee. Senator Yancey McGill explained the agreement. Mr. Lazarus requested Mr. Foxworth represent Council as a member of Mr. McGill's committee to oversee the bid process and study for the regional airport. **Mr. Foxworth called previous question to the amendment to the main motion. The amendment to the motion passed unanimously. The amended motion passed unanimously.**

Resolution R-147-05 to approve the sale by the Solid Waste Authority of a 0.32-acre parcel located along Hwy 57 in the Little River Township. **Mr. Lazarus moved to approve, seconded by Mr. Prince. The motion passed unanimously.**

Mr. Prince moved to defer, seconded by Mr. Hardee.** Mr. Boyd requested that an Ad Hoc Committee on Mining be appointed by the Chairman to address concerns of the mining industry. He suggested Mr. Lazarus, Mr. Barnard, and himself serve on the committee. Mr. Frazier volunteered to serve. The following people spoke:

Ms. Carter explained the Planning Commission’s recommendation. Mr. Worley stated the developer, Mr. Shep Guyton, had agreed on GR-8 zoning with a height cap of 35 ft. Mr. Guyton confirmed that agreement. **The motion to approve passed.** The vote was as follows:

Legal briefing – Contractual Matter – Myrtle Beach International Airport. Mr. Weaver discussed HNTB Architecture’s request for additional fees to complete design plans for the new terminal. Staff had negotiated a \$6.5 million increase to bring the design to 65% and 100% completion. He advised there were two options for consideration: 1) accept HNTB’s \$6.5 million proposal, or, 2) reject their proposal and require compliance with the original contract. **Mr. Barnard moved to receive a cost estimate (to construct**

Property Tax Reform and Development. Mr. Foxworth spoke regarding the discussion of property tax reform at the Administration Committee and the Budget Retreat. The Senate and House subcommittees met and the proposal would discontinue property taxes on homes, keep property taxes for businesses, discontinue sales tax on groceries, and increase sales tax on everything else. The County’s ability to increase the taxes on businesses would be capped and services would be tied to personal income growth statewide. Mr. Foxworth requested the I&R Committee begin working on an ordinance ready to act on after the first of the year that would link growth and local government and issues of building permits on statewide personal income growth. Mr. Barnard agreed, but requested Mr. Foxworth’s guidance.
