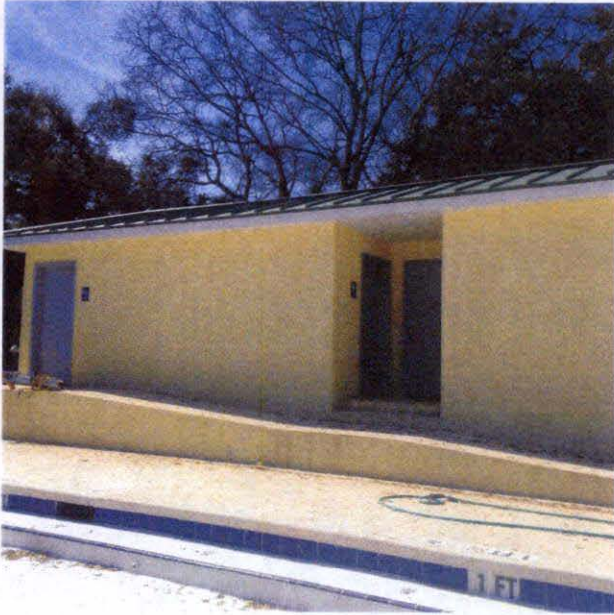

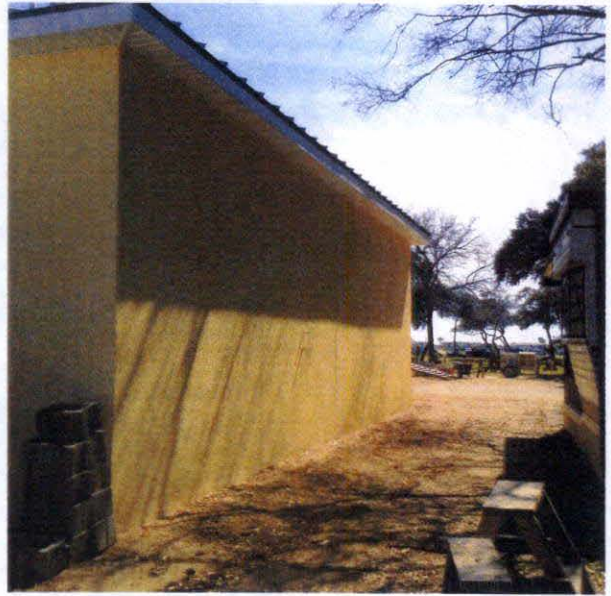

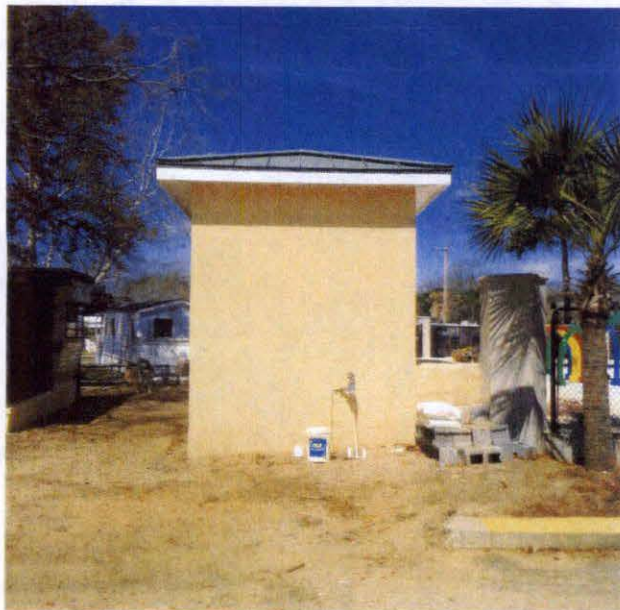


FRONT VIEW
