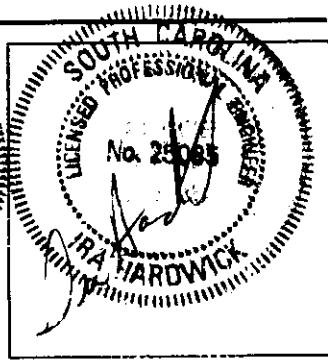

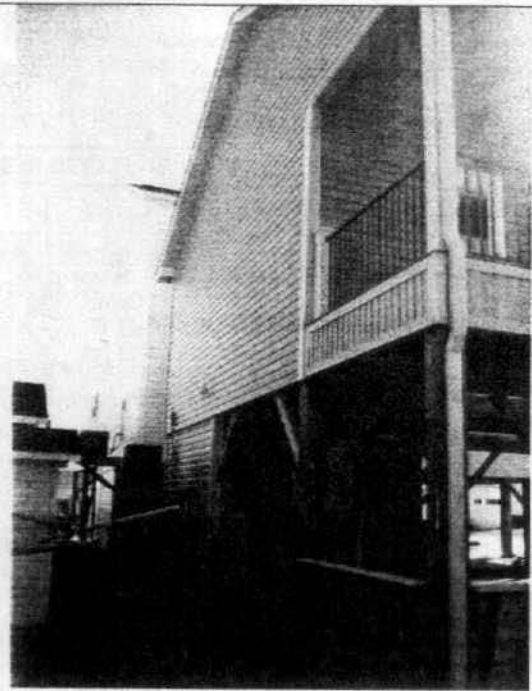

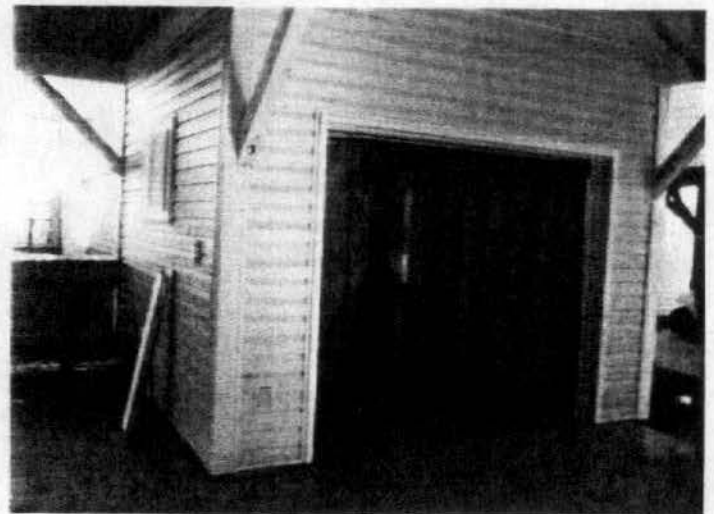
Front View (1-18-10)
