**OLD/NEW BUSINESS:**

**Update on the Kost Bill implementation.** Mr. Weaver asked if the Kost Bill was still applicable now that the School Board’s local option sales tax on debt reduction had passed and the state law on operating expense had also passed. Mr. Lazarus stated it was applicable in that it brought the added revenues into the County. Mr. Weaver stated he would write a letter to the town managers and mayors to inform them of the County’s action.

**Update on RIDE II.** Mr. Gosnell stated that staff had begun working with the SC Department of Revenue on implementing the capital projects sales tax in May 2007. Staff was also working on the procedures for letting contracts for the 100 miles of road improvements. A timeline for the construction will be presented at the December Council meeting. Frannie Heizer, McNair Law Firm, advised that a Resolution to formally adopt the official results of the referendum would need to be acted on at the December meeting. She recommended that a Reimbursement Resolution be adopted so that any monies that might be spent or advanced could be reimbursed to the County from the proceeds of any tax exempt bonds that might be issued.
