**The motion passed unanimously.**

#### **RESOLUTIONS/PRESENTATIONS:**

**Resolution R-187-08** honoring William David “Billy” Witherspoon for a career of distinguished civic service. Mr. Hardee presented the resolution to Mr. Witherspoon. **Mr. Prince moved to approve the resolution, seconded by Mr. Schwartzkopf. The motion passed unanimously.**

Ms. Gilland presented a plaque to Mr. Hardee thanking and honoring him for his years of service on County Council. Mr. Hardee thanked everyone.

Presentation of the financial report for the year ended June 30, 2008. Laurie Smith, Elliott Davis Accountants, gave a presentation on the financial report stating there were no significant difficulties encountered. There were no disagreements with the management and no uncorrected misstatements that were uncovered during the audit and no proposed audit adjustment interest.

#### **READING OF ORDINANCES:**

Third reading and public review of **Ordinance 97-08** to amend the County Code regarding watercraft and motors subject to ad valorem property tax in Horry County as authorized by the SC Code of Laws. **Mr. Hardee moved to approve, seconded by Mr. Worley.** There was no public review. **The motion passed unanimously.**

Third reading and public review of **Ordinance 140-08** to approve the request of Eric Rabon, Shoreline Engineering LLC, agent for Conway Atlantic Land Development LLC, to amend the official zoning maps. **Mr. Frazier moved to approve, seconded by Mr. Hardee.** There was no public review. **The motion passed unanimously.**

Second reading and public review of **Ordinance 141-08** to amend the zoning ordinance pertaining to public utility installations. **Mr. Worley moved to approve, seconded by Mr. Hardee. Mr. Hardee moved to approve the amended version in the packet, seconded by Mr. Prince.** Reed Cooper, Horry Electric Cooperative, spoke at public review. **The motion to approve the amended version passed unanimously.**

Second reading and public review of **Ordinance 142-08** to amend the zoning ordinance pertaining to monthly disclosure of utility operations in Horry County. **Mr. Hardee moved to approve the amended version in the packet, seconded by Mr. Barnard.** Pam Creech spoke at public review. **The motion passed unanimously.**

First reading of **Ordinance 146-08** to amend the FY2008 budget so as to reduce the authorized transfer from the general fund to the capital projects fund by \$2.8 million and to delete that portion of the projects from the capital projects fund. **Mr. Barnard moved to approve, seconded by Mr. Prince. The motion passed unanimously.**

**Resolution R-186-08** authorizing the county administrator to use \$4 million of bond proceeds from the 2008 general obligation bonds to finance the North Strand Recreation Center. **Mr. Prince moved to approve, seconded by Mr. Worley. The motion passed with Messrs. Barnard, Foxworth, Hardee and Schwartzkopf voting nay.**

#### **OLD/NEW BUSINESS:**

At-Large Appointment to the Zoning Board of Appeals, one seat: Nominees were Judy Price and Steven Neeves. Ballots were distributed earlier in the meeting. Judy Price was appointed to the Zoning Board of Appeals by ballot.

Chairman Gilland spoke briefly on the current economic times and encouraged all County employees to come up with suggestions on cost savings.

Mr. Barnard thanked Mr. Hardee for his work on Council and that he enjoyed working with him.
